Will of John Flynt from Stokes County Estate Files, John Flynt, 1821

In the Name of God Amen, I John Flynt of the County of Stokes & state of North Carolina Being in sound mind and Memory, Blessed be god, and its Veary uncertain of what Duration my Days may be in time, Do Constitute this my Last Will and Testament in Manner and Form, Following, to Witt, -

First I give my Soul into the hands of almighty God, and my Body to Be buried in a Deacent Manner, at The Directions of My executors, hearafter to be Nameed (sic), in hopes of a Joyfull Resurrection Through Jesus Crist my Lord & Saviour,

- First, I give & Bequeath unto my beloved wife Catherine Flynt My hous and Land and Houshold Furniture, also Negro mime & Delf & as much of the stock as she may Think proper to leas, For her Life time after her Death Negro Delf is to Be my son Richard Flynts property Negro, Mime is to be at Liberty to go & live with which of the Children as She may see cause, the houshold & stock sold & Eaquelly Devided

I give & Bequat unto my **son Richard Flynt** my hous & Land I give To all my Dauters One Hundread Dollars Extrodinary more than The Boys.

I give unto my Dauter Fanny & her Airs on hundread Dollars For Ever,

I give to my grandchild Airs of my son Merideth Flynt one hundread Dollars for Ever, I give unto my Grand Dauter Polly Redman Fifty Dollars - My grandauter Elizabeth plummer I wish to have a full shear with the Rest of My Daughters - Then For My hole Estat, to be Equally devided amongst all my Serviving Children Except my son Richard Flynt his Part is above Mentioned

Lastly I appoint my **son Richard Flynt & John Reddick** my Executors of my hole Estate to mannage as hearin Directed
