George Freeman (son of Holman Freeman, Sr.), b Va 1758. Mar. in Va Frances (called Fanny) Taylor. Moved to Wilkes Co., Ga. (then the "Ceded Lands") in 1772. Served under Gen. Elijah Clarke in Ga. Militia and was at the Siege of Augusta. He d. Wilkes Co., Ga. May 12, 1796. She d. 1820.

He served during the Rev. under Gen Elijah Clarke; was at the Siege of Augusta and served throughout the War. He was also a Sol. of the war of 1812 as Col of Batt. He mar. about 1783, Peninah Walton (sister of Josiah Walton, of the Broad river Settlement). She was b. Va. d. Ala., where she removed after her husband's death in Wilkes Co 1817.

John Freeman (son of Holman Freem Sr.) b Va 1756 d "Poplar Grove," Wilkes Co., Ga Jan 7 1807. Served under Gen Elijah Clarke; was at the Siege of Augusta and Charleston, S.C. fought under Pickens, Sumpter, and Morgan in S.C. Was with Count D'Estang at Savannah, Ga. After Savannah was siezed by the British, the Freeman brothers joined ith Va Army; he was made Captain; later joined Gen Greene and was at Battle of '96. He mar. 1785 Catherine Carlton(dau of Robert Carlton, a Rev. Sol. of Va., d. Wilkes Co., Ga, and his wife Rebecca.)

Their only child:

Rebecca Freeman (1786-1843, mar. Oct 6, 1803, **Shaler Hillyer** (son of Asa Hillyer, Rev Sol. of Conn, and his wife, Rhoda Smith). He was b. Conn., Aug 2 1775 d. Wilkes Co Ga Mar 22, 1820.

William Freeman (son of Holman Freeman, Sr.), Mar. Sally. -- Lived in Augusta, Ga. Was a Rev Sol of Ga

He served as Rev Sol in Va and in Ga; served under Gen Elijah Clark at the Battle of Kettle Creek: received a grant of 287 1/2 acres land for his service on Shouldrbone Creek, Washington Co., Ga Sept 1, 1794 he willed "the 650 acres where I now reside (formerly Wilkes Co.) and the 287 1/2 acres in Hancock Co., received for my service as a Rev. Sol" to his children by (2) wife. He d. 1797; his (2) wife d. before this, about 1795.
